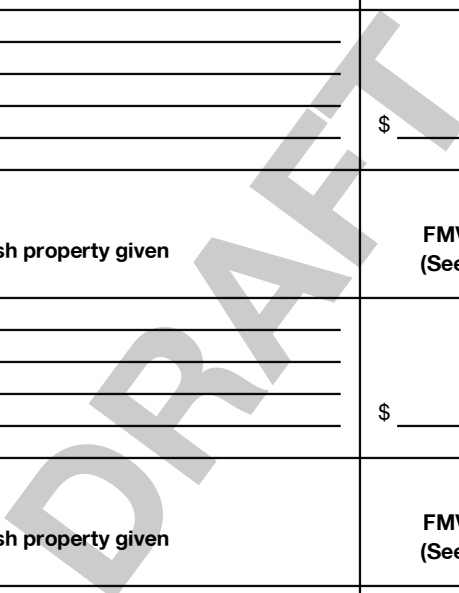

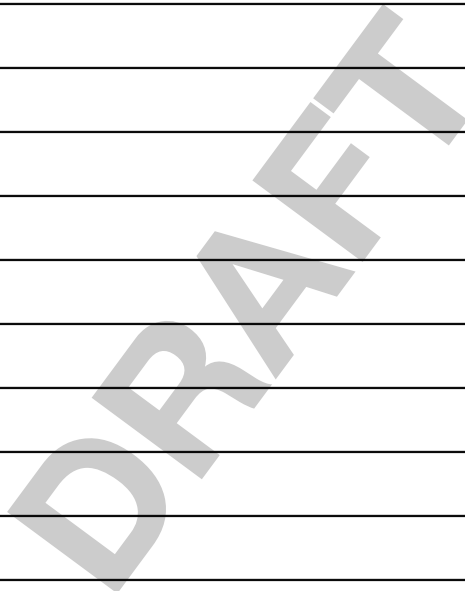

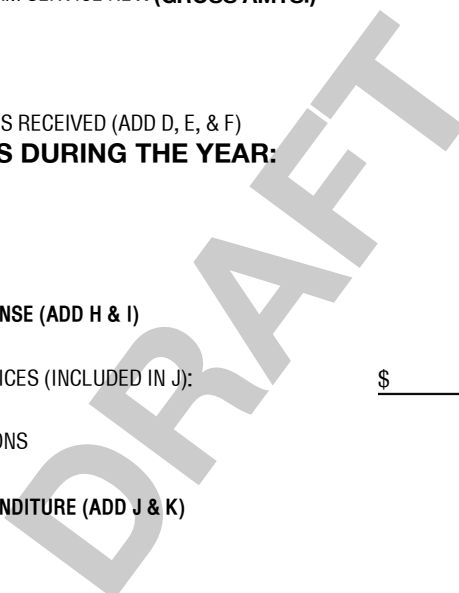

MISAPPROPRIATION IDENTIFIED

IN DECEMBER 2017, CHF LEARNED OF THE POSSIBILITY THAT ITS THEN CURRENT EXECUTIVE DIRECTOR MAY HAVE BEEN DISHONEST IN HIS HANDLING OF THE AFFAIRS OF CHF. CHF'S EXECUTIVE COMMITTEE, BOARD OF DIRECTORS, AND OUTSIDE LEGAL COUNSEL ACTED IN A MANNER CONSISTENT WITH APPLICABLE LAW TO ADDRESS THE SITUATION BY: (I) TERMINATING THE EXECUTIVE DIRECTOR'S AUTHORITY TO TRANSACT BUSINESS ON CHF'S BEHALF BY REMOVING HIS NAME FROM ITS CREDIT CARDS AND BANK ACCOUNTS; (II) COMMENCING A COMPREHENSIVE FORENSIC AUDIT TO DETERMINE THE EXTENT OF THE MISMANAGEMENT AND MISAPPROPRIATION AND TO DETERMINE WHETHER OTHER EMPLOYEES, OFFICERS, OR DIRECTORS WERE INVOLVED IN OR AWARE OF THE EXECUTIVE DIRECTOR'S MISAPPROPRIATION OF CHF'S FUNDS; AND (III) PROMPTLY HIRING AN INTERIM EXECUTIVE DIRECTOR WHO BROUGHT EXPERIENCE IN FINANCE, MANAGEMENT AND STRATEGIC PLANNING. THE FORENSIC AUDIT FOUND THAT THE FORMER EXECUTIVE DIRECTOR HAD MISHANDLED AND MISAPPROPRIATED APPROXIMATELY \$770,000 OF CHF FUNDS RAISED FOR THE PERIOD OF 2011 THROUGH NOVEMBER 30, 2018. CHF REPORTED THIS MATTER TO THE ILLINOIS ATTORNEY GENERAL'S OFFICE IN FEBRUARY 2018 AND TO THE U.S. ATTORNEY'S OFFICE IN MARCH 2018.

SINCE FIRST LEARNING OF THE POSSIBLE MISAPPROPRIATION OF FUNDS BY ITS FORMER EXECUTIVE DIRECTOR, CHF HAS TAKEN SEVERAL STEPS TO PREVENT ANY FUTURE ACTS OF THEFT, INCLUDING: (I) IMPROVING SEGREGATION OF DUTIES BETWEEN ACCOUNTING AND CASH DISBURSEMENT FUNCTIONS; (II) ESTABLISHING PROPER REVIEW PROCEDURES FOR CASH DISBURSEMENTS; (III) REVIEWING ALL EXECUTIVE DIRECTOR EXPENDITURES BY A MEMBER OF THE EXECUTIVE COMMITTEE; AND (IV) ELIMINATING CASH WITHDRAWALS FROM CHF ACCOUNTS VIA AN ATM. IN ADDITION, CHF IS UNDERTAKING A REVIEW OF ALL FINANCIAL PROCESSES, CONTROLS, AND ASSURANCE ACTIVITIES, INCLUDING CHANGES TO BANKING RELATIONSHIPS TO STRENGTHEN BANKING CONTROLS.
